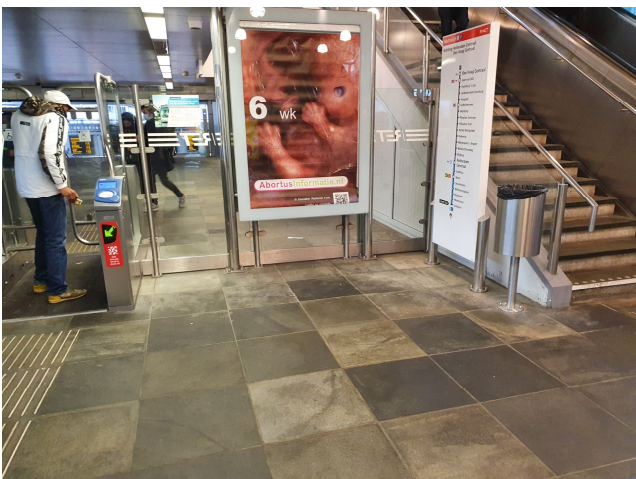

Introduction

AbortusInformatie.nl is an innovative human rights NGO organisation that started 40 years after the first abortion clinic opened in the Netherlands, which was the Arnhem Mildredhuis, on 27 February 1971.

Exactly 40 years later, 27 February 2011 AbortusInformatie.nl was launched. AbortionInformation.eu is our English name.

Human rights organisation

AbortusInformatie.nl is a human rights organisation that educates about abortion.

We are against all forms of violence relating to abortion. Everybody has their own opinion on the topic and different ways of thinking, but violence is not the answer.

Abortusinformatie.nl was set up by women who regret their abortion. We missed crucial information in the decision making process of our abortion.

Many of us say that if we had realized certain things in advance, and seen the images of what babies can look like after enduring an abortion, we would not have made the decision to kill our own offspring through abortion - we would have found other alternatives for the situation we were in.

All board members have affinity with abortion.

We build awareness on the reality of abortion, so that true 'informed consent' can be given based on facts and true understanding.

We do this amongst others by showing medical scientific images.

AbortusInformatie.nl also helps women considering abortion, who decide to keep their baby, or regret their abortion afterwards.

We bring innovative new ideas to the country, and as trailblazers have vision, and are entrepreneurial!

There are no hired employees. Work was carried out by unpaid volunteers. These were engaged in supporting our work for our projects in the short and long term.



Strategy

Because we find it inhumane that arms and legs are torn off children, babies are poisoned, starved or beheaded and their lives intentionally prematurely ended through abortion, we started this human rights organization. In Dutch, our foundation is called AbortusInformatie.nl, in English AbortionInformation.eu

1. The goal of the foundation is
 - (a) to be active in the area of human rights, sexuality, abortion and the possible consequences of it, amongst others, by providing information, support and shelter;
 - (b) carry out further actions which, in all senses of the word, relate to or could be conducive to above mentioned areas.
2. The foundation aims to achieve her goals, amongst others, by:
 - (a) providing information and education to promote public awareness on abortion: procedures, consequences, experiences and development of a baby in the womb;
 - (b) supporting women with an unplanned pregnancy (medical, material, financial, emotional and mental help), also after the birth of their baby;
 - (c) offering special provisions and courses for parents and the child, in order to promote their well being;
 - (d) setting up 'abortion information centers', a contact point for forced abortions, and organize platform days, symposia and theme days;
 - (e) providing opportunities for help after abortion (or sexual abuse) through so-called healing groups/retreats, peers' days, commemorative monuments and/or memorial services; the foundation also aims to offer women (post abortion) consolation, information, support and healing;
 - (f) providing sexual education to help prevent unplanned pregnancy (prevention through education), sexually transmitted diseases STD's etc., as well as offering medical diagnosis of STD's and other related diseases;
 - (g) attention to monitoring and ensuring implementation of due care standards surrounding abortion, also availability of an adequate offer of legal assistance with regards to the abortion issue;
 - (h) promoting the kind of legislation and regulations, as a result of which more restraint and a careful approach towards abortion will be taken, with more options coming into being for expectant mothers to give up their (not yet born) baby, as well as issuing advice and proposals to the government in this matter;

all in the broadest sense of the word.

The foundation aims to operate on both micro and macro level. The foundation is open to cooperation with other individuals and/or legal entities as well as with other organizations in the above mentioned areas.

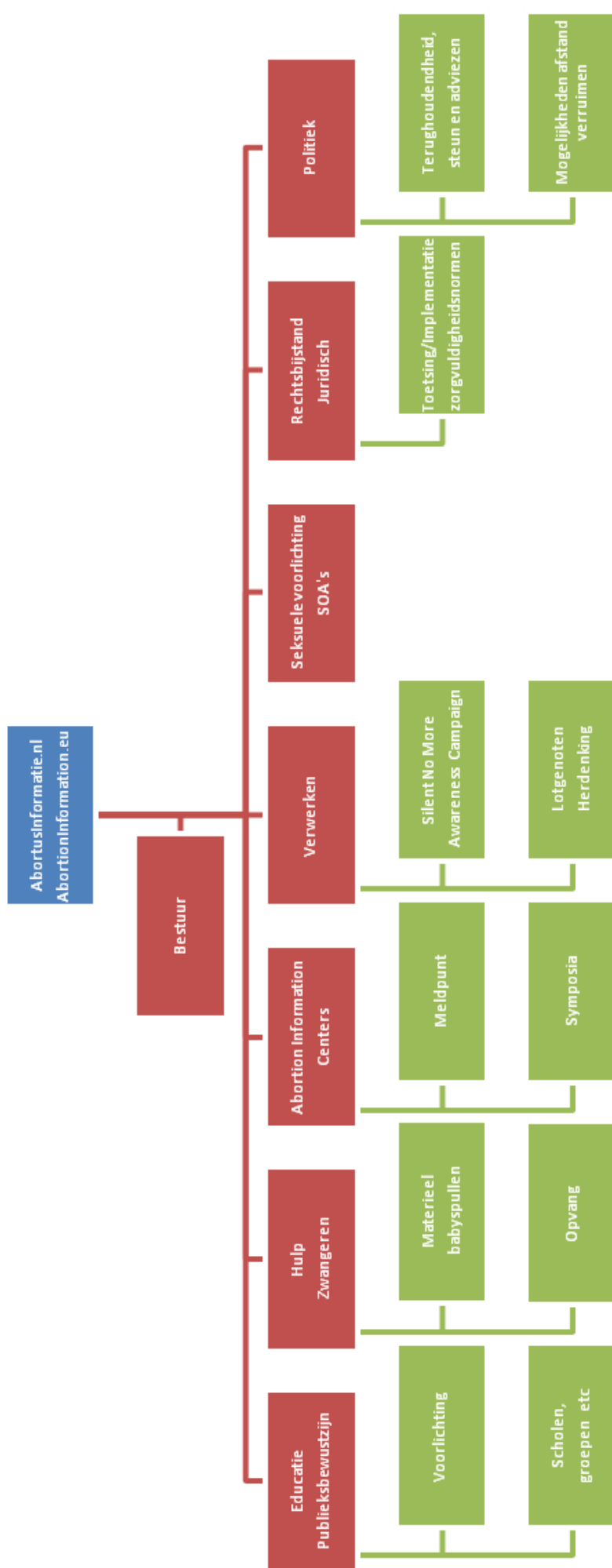

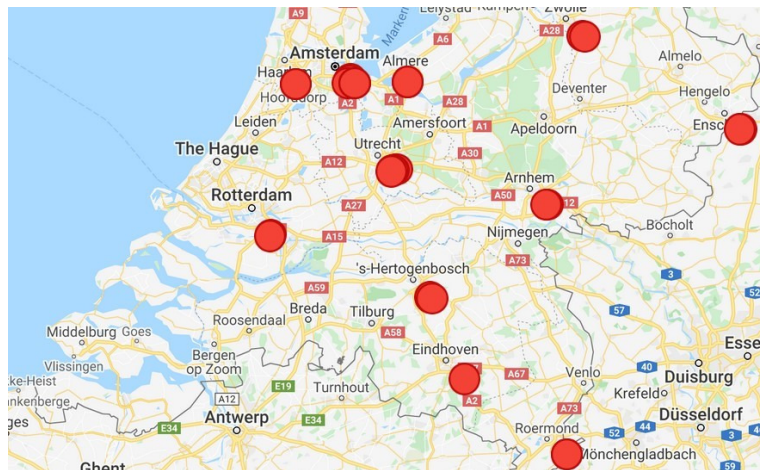

CBR-Netherlands Confronts Abortion Promoters

International CBR affiliates routinely rely on our legal input to assist them as they carry out public abortion photo displays. It is important to note that without the First Amendment, our international friends encounter challenges beyond what we face in the U.S. This week, CBR-Netherlands Founder Salome van der Wende emailed us to say thank you: We are very grateful for all the prior legal help, which has once again shown that we are within our rights. Thank you, Gregg, for all your advice over the years, which we included in the response we had sent the evening prior [to the Zwolle mayor], which also included judicial advice from various people here in the Netherlands.

Ms. van der Wende has reported that CBR-Netherlands did not know for four months where they stood with authorities from the city of Zwolle. When CBR-Netherlands (AbortusInformatie.nl) displayed abortion and prenatal signs on August 18, 2020, World Humanitarian Day, they

were threatened with legal prosecution. The law varies from town to town and permission to display photo signs must be granted by the mayor. In December, Ms. van der Wende sent the mayor a letter asking for clarification, specifically asking if authorities could substantiate their claims, and inquiring whether legal action would be taken if CBR did future displays. Two weeks later, she finally received a response from the Zwolle council. We quote, in part:

The BOAs [Buitengewoon opsporingsambtenaar - investigative officers] who were on the scene at your demonstration in August also tried, in collaboration with the police, to assess whether the materials you use in the demonstrations are permissible under criminal law. It has not yet been shown that it is inadmissible. So no legal action will be taken against you.

The council avoided the question of whether CBR-Netherlands' photo displays can be deemed "offensive" and "hateful," arbitrary words which were included in a Zwolle regulation given to CBR. Violations could result in up to two months in jail and a fine. AbortusInformatie.nl had an earlier run-in with authorities in Zwolle in 2015.

Meanwhile, babies continue to be aborted, so CBR-Netherlands sent an email reply to the council and proceeded with a photo sign display the following day. Ms. van der Wende carried with her the letter she wrote to the council in which she requested knowledge of the laws pertaining to council demands. She presented the letter to the two BOAs and two female police officers who appeared on the scene that morning, seemingly to sabotage their freedom of speech.

The four officials refrained from shutting down the display, but one of the BOA agents hinted that they may yet attempt to stop CBR-Netherlands' displays. The agent indicated

that they will not make a police report, but they are going to investigate and offered, "You are entitled to a lawyer." CBR-Netherlands lacks consistent aid from pro-life lawyers, in spite of our efforts to recruit such help. A number of European lawyers who claim to be Christ followers have refused to defend the expressive rights of CBR affiliates. Here in the U.S., our lawyers at the American Freedom Law Center have effectively represented us for years.

CBR-Netherlands stands up for unborn children and their mothers with a small number of volunteers and supporters, but they make up for their size in courage. Recently, they confronted the Dutch politician Lillianne Ploumen, a fierce abortion advocate who initiated SheDecides. When President Trump reinstated the Mexico City policy, which ended U.S. funding of abortion overseas, Ms. Ploumen solicited international money to keep aborting babies in the third world, as well as the babies of women who travel from countries where abortion is restricted (e.g. from Poland to Holland).

CBR-Netherlands Founder Salome van der Wende was waiting to meet Ms. Ploumen as she stepped out of a taxi to enter an Amsterdam meeting where she was scheduled to speak. A television crew actually recorded their discussion and aired it on prime time television. The coverage also included another CBR-Netherlands photo display held in The Hague.

This was not the first time CBR-Netherlands held Ms. Ploumen accountable. When she was collecting international abortion money in Brussels, Belgium, in 2017, Ms. van der Wende and other pro-life groups were present with abortion photo signs and other graphic reminders of the horror of abortion.



CBR-Netherlands stood with signs outside the International Peace Palace on the 75th anniversary of the UN Peace Day. This Peace Palace is the seat of the International Court of Justice of the United Nations in The Hague. Spiritual darkness is apparent in this place in contrast to its name.

reported by *Volkkrant* to have "raised hundreds of millions of euros to (partially) close the hole left by Trump." If true, this figure did more than "close the hole," as the reputable Population Research Group reported: "President Trump's Mexico City Policy has slashed an estimated \$153 million in U.S. international aid dollars to foreign organizations that perform or promote abortion overseas, a report from the U.S. Government Accountability Office (GAO) has found." (<http://bit.ly/2KRZD0m>)

CBR-Netherlands' outreach extends beyond Holland. On December 28, 2020, Ms. van der Wende wrote the Argentinian Senate as they deliberated the legalization of abortion. With the assistance of CBR-Spain's director Jorge Benito, Ms. van der Wende sent 72 letters personally addressed to each senator. She included CBR majority photos of babies ages 6 to 10 weeks. Although a majority of the Argentinian Senate (38 to 29) voted to make abortion

There are international life-and-death consequences when U.S. Presidential elections are held. A January 18, 2021 article in the Dutch publication *de Persgroep* lamented the effect of President Trump's decision to reinstate the Mexico City policy, first enacted in January 20, 1985 by the Reagan administration, to prevent US government funds from being used directly or indirectly to facilitate abortion elsewhere in the world.

This policy has been dubbed "the gag rule" by pro-aborts, and it has see-sawed back and forth with each presidential election. When a Republican president has been in office, babies' lives are spared. When a Democrat wins, more babies die at millions of abortion dollars flow out from the U.S. The pro-aborts crave funding to carry out their evil work.

Predictably, President Biden rescinded the Mexico City policy on his first day in office, reopening the blood money fund. The *Volkkrant* article lamented the effectiveness of "the measure by which Donald Trump mercilessly cut international programs for the reproductive health of women and girls in 2017." What is merciful about killing babies and destroying family lines forever? SheDecides 3.

Algemeen

Inschrijving handelsregister

De onderneming is ingeschreven in het handelsregister van de Kamer van Koophandel voor Amsterdam onder nummer 51864517

Doelstelling

De stichting heeft ten doel: werkzaam zijn op het gebied van mensenrechten, seksualiteit abortus en de mogelijke gevolgen daarvan, door onder andere het bieden van voorlichting hulp en opvang; het verrichten van verdere handelingen, die met het vorenstaande in de ruimste zin verband houden of daartoe bevorderlijk kunnen zijn.

De stichting tracht haar doel te bereiken door:

- a) het verstrekken van educatieve voorlichting ter bevordering van het publieksbewustzijn omtrent abortus: procedures, gevolgen, ervaringen en ontwikkeling van een baby in de baarmoeder;
- b) hulp bieden aan vrouwen die ongepland zwanger zijn (zowel medisch, materieel, financieel, emotioneel en geestelijk) ook na de geboorte van hun kind;
- c) het aanbieden van bepaalde voorzieningen en cursussen voor ouders en het kindje, ter bevordering van hun welzijn;
- d) het opzetten van "abortion information centers", meldpunt voor gedwongen abortussen, alsmede het organiseren van platformdagen, symposia en themadagen;
- e) mogelijkheden bieden voor het verwerken van abortus (of seksueel misbruik) door middel van zogenaamde verwerkingsgroepen, lotgenotendagen, herdenkingsmonumenten en/of herdenkingsdiensten; daarbij streeft de stichting ernaar om vrouwen (na een abortus) troost, informatie, ondersteuning en heling aan te bieden;
- f) het verstrekken van seksuele voorlichting ter voorkoming van ongeplande zwangerschappen (preventie en educatie), SOA's, etcetera, alsmede het aanbieden van medische diagnose van SOA en aanverwante ziektes;
- g) zorg te dragen voor toetsing en implementatie van zorgvuldigheidsnormen met betrekking tot abortus, alsmede zorg te dragen voor een adequaat aanbod van rechtsbijstand in het kader van de abortusproblematiek;
- h) het bevorderen van een zodanige wet- en regelgeving waardoor meer terughoudendheid en zorgvuldigheid wordt bewerkstelligd bij een abortus en waardoor meer mogelijkheden ontstaan voor aanstaande moeders om afstand te doen van hun (nog ongebooren) kind, alsmede het ter dier zake uitbrengen van adviezen en voorstellen aan de regering;

Alles in de meest ruimste zin des woords.

De stichting streeft ernaar om werkzaam te zijn op micro niveau en macro niveau. De stichting staat open voor samenwerking met andere natuurlijke personen en/of rechtspersonen danwel andere organisaties op genoemde gebieden.

De stichting is opgericht voor onbepaalde tijd;

Het vermogen van de stichting zal worden gevormd door sponsoring, subsidies en donaties schenkingen, erfstellingen en legaten en andere verkrijgingen en baten.

Het bestuur bestaat uit een voorzitter, secretaris en een penningmeester.

Comments

The board is grateful for all the generous donations this year, which allowed us to continue this work.

In 2021 we were able to, amongst other things, do the following:

- Held advertisement campaign in 11 cities along streets/busstops/metro
- Aired a 30 second commercial on TV
- Printed new awareness signs
- Items for healing retreats to work through a past abortion
- Made baby models
- Some travel expenses

Along with this, office supplies such as A4 paper, SD's/USB's, operational costs such as websites, phone, admin software, insurance, banking, post office box etc.

Activites

In 2021 we launched our new website on 12.3.21.

We expanded our visibility on social media, posting more on twitter and instagram, next to facebook. We also diverted to various other video platforms due to censorship issues with Youtube. Posts on social media have been covered because it might show "unnecessary bloodshed".

We continued our public education work with some awareness displays, including an advertising campaign in 11 cities, showing an image of a 6 week baby from conception in the womb, along streets/busstops/metro. Humanistisch Verbond and Abortion Network Amsterdam, amongst others, did not agree.

We also aired a 30 second commercial on ATV.

The STER NPO123 however at almost the last minute sabotaged airing.

After notifying the minister responsible for media in our government, they changed their stance, and now allow the airing of the commercial.

We had 3 court cases for showing an image of a 6 week unborn baby along the streets, which we all won. On the sign it said the age was from conception. Our advertising campaign led to a lot of complaints and publicity.

Haarlem council discussed us, and Utrecht council discussed us for advertising on the street earlier in the year, and educating youth at the Utrecht University (twice) later in the year.

Upon request gave input during the United Nations women NGO CSW65 virtual forum in New York. Also per request made a video regarding the dangerous ESA partnership plans of EU with Africa to give majority of 106 votes in the United Nations, enabling passing of (binding) resolutions worldwide.

Work on healing programs continues www.abortusverwerken.nl, along with the advisory role for another healing program we helped set up/initially translated. We created various videos, and per request translated 'So you're pregnant' by Choice42.



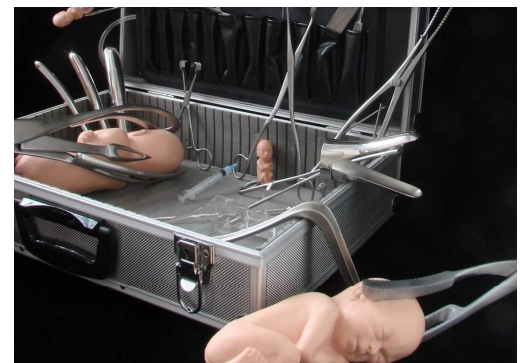

A meme was made by Celebrate Life Magazine – a regular subscription magazine of American Life League. A popular post reached over 15.000.

We showed an image of a baby during the March for Life, along with visiting the abortion clinic in Eindhoven in remembrance of the abortion law, and various other activities.

Following an earlier run-in with authorities in Zwolle, we received a letter on behalf of the mayor of Zwolle that we had not done anything wrong. The next awareness display though, the BOA's again breeched their authority.

Although in 2019 we had around 200 requests for help, and in 2020 170 requests for help, this number became much lower in 2021 following a message "Ik ben deel van een organisatie die er tegen is van leugens te verspreiden op het net. Ik kom eerlijk met m'n naam te voorschijn omdat een stel sukkels zoals jullie me toch niets kunnen. Wees bereid om je site gehakt te hebben en al wat jullie willen geblokt te hebben. Een vrouw kiest wat er met haar lichaam gebeurt en daar hebben een stel sukkels zoals jullie niets mee te maken. Get ready."

Various babies were born.

We had a lot of media attention, and long interview with Investico.

Some of our images were briefly included in NOSstories, and BOOS.

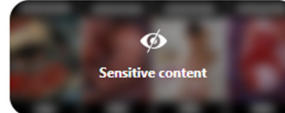
